 - Looseness of indentures. Lack of policy & procedures, roles
 - Communication with homeowners
 - Lot upkeep
 - Assessments and special assessments.
 - Distributed assessments for services (trash, snow, mowing, etc)
 - Board elections
 - Current Amendment 5 Process to remove a board member
 - Ballots 5,7 & 8 distributed by the prior board not a current priority
- Discussion
 - Suggestion to rewrite the WTOA bylaws as a whole
 - Sandi concerned with length of time to achieve all the changes and suggested in the Boards best interest to address the areas that are most limiting.

 - Paragraph 5 (line 179), 6 (line 210), 7 (line 227)
 - Clarify the language
 - Annual assessment
 - Special assessment
 - Distributed assessment for services
 - Interest for late payment
 - Yearly budget to allow the board operating costs
 - Liz Valuable knowledge working for a Title Company
 - Judges in title cases are hyper-literal
 - Amendment 5
 - Clarification on reasons to remove board members
 - 35% to achieve seems to be a very low # of residents. See other HOAs

Wilderness Trails Owners Association Restrictions Committee Meeting – 11/4/2020

- Ben concerned with a 75% majority to pass an action. This means that 25% of owners can block an initiative.
 - Consider a quorum
- John Prior proposals are just concepts.
- Sandi Policies and procedures should enhance the bylaws.
 - For instance, interest rates may climb. The board should be able to adjust the interest rate as needed without changing the bylaws. Consider a cap on interest rates at 10% plus WSJ prime rate. Or consider maximum allowed by law as upper limit.
- Consider a Road Plan past 5-year plan for roads exists and needs updating
- Bylaws have no language to enforce paying for services (trash/snow/mowing).
- Enforcement of bylaws.
 - Consider a fine for violation of bylaws
- Rewrite the bylaws and use policies and procedures to define how to achieve the bylaw.
 - Delinquencies, liens, interest, etc.
- Mechanic's lien as mentioned in the bylaws is outdated.
 - HOA liens are used these days
- Based on the increased road costs over the past 5 years, may need to consider increasing the yearly assessment
 - Spending more on roads than collected in assessments over the last 5 years.
- Align the board elections and board terms
- Next Steps

Teams assigned and will generate proposals for discussion at the next meeting. Each team will review sections of the current WTOA bylaws as assigned. Then will compare with 6 other HOA bylaws for suggested changes. (*Sandi to send 3 more sets of HOA bylaws to team.*)
