

**Proposed Amendments to the  
Declaration of Dedication and Restrictions  
for the Wilderness Trails Community**

(as recorded in book 383 on page 1661 on December 2, 1987)

Paragraph seven (7) of the section of the Declaration of Dedication and Restrictions entitled Board of supervisors currently reads as follows:

7. The Board is empowered to enter into contracts for the maintenance of roadways and for other improvements it might deem necessary or advisable. The Board is further empowered to borrow funds, not to exceed \$25,000.00, to provide for such maintenance or improvement. Such a loan may only be made by vote of the majority of the owners of land within the area described on page 1 of this indenture together with the owners of any lands added by addendum.

Said paragraph seven (7) shall be amended, upon the action of seventy-five (75) percent of the owners pursuant to the general provision of said declaration, to read as follows:

7. The Board is empowered to enter into contracts for the maintenance of roadways and for other improvements it might deem necessary or advisable. The Board is further empowered to borrow funds, not to exceed \$25,000.00 to provide for such maintenance or improvement. Such a loan may only be made by vote of the majority of the owners of land within the area described of page 1 of this indenture together with the owners of any lands added by addendum. In addition to the powers granted above, the Board is empowered to obtain an additional one time \$35,000.00 loan for the paving of the remaining roadways in the subdivision. Acceptance of this amendment would allow the Board to borrow this additional amount.
